



RESIDENCE MOBILE DE LOISIRS LOCATION CONTRACT

Reservation is made by filling this form and is confirmed after our approval depending on our disponibilities.

Each location is personal and can't be ceased or sub-rented in any case. The maximum number of people can't exceed the authorized capacity of the residence. Our tariffs include one vehicule only. Guests and other supplements must be signalled and discharged. Rules of procedure inside the camping are given at your arrival.

Installment is required for your reservation to be effective : if your booking is made more than 30 days before your arrival, you will be charged 25% of the total amount of the location. In case you book less than 30 days before your arrival, you must discharge the whole location for your location to be effective.

The whole stay must be payed within 30 days before your arrival, without any recall from us. If your stay is not totally payed before your arrival, we have right to cancel your reservation and installement will not be refunded. No refund is accepted either if you arrive later or go sooner than planned. Without any telegraphed confirmation if you differ your arrival, the location is made available 24 hours after the date planned by contract and your payment remains required.

Duration of location :

Low Season : two nights minimum

Tourists Season (jully-august) : one week minimum, from the saturday 3pm (arrival) to saturday 10am (departure)

In case of cancellation you will be charged :

A) 25% of the total amount of the location if you cancel more than 30 before your planned arrival.

B) The total amount of the location if you cancel 30 days or less before your planned arrival or if you're not present at this date.

A guarantee of 300 € is versed when you receive your keys, it is be restitued at your departure eventually deducted by repair expenses and the value of destroyed / missing material. **A fixed price of 50 € is retainable on the guarantee if the location is not restitued in the best possible conditions of cleanliness.** This guarantee is not a replacement of responsibility, the tenant must have his own civil responsibility insurance. Any dissension concerning the interpretation or application of the current contract will be discussed within the competent court in Coutances.
